4. Firm has to make arrangement of required manpower for supply/serving of food and refreshments.
5. Number of refreshments/lunch to be supplied as indicated in the menu are tentative and actual quality will be mentioned in the supply order.
6. Cleaning of venue after completion of the refreshment and lunch will be the responsibility of the selected firm/ agency.
7. The firm has to submit tender fees of Rs. 500.00 (Rupees Five Hundred) in shape of Demand Draft in favour of Director, ICAR-NRC on Pig, Guwahati along with Tender Document. Tender fee is Non refundable.
8. The Quotation(s) should be sealed and Superscripted on cover “**Quotation for supply of Refreshments/Lunch on 04.09.2017**” and addressed to the undersigned.
9. The rates Quoted (in Indian Rupees) should be F.O.R. ICAR - NRC on Pig, ICAR, Rani, Guwahati-781131 including VAT/Taxes. VAT & Taxes should also be shown separately.
