NOTICE FOR INVITING TENDER THROUGH E-PROCUREMENT

Online Bids are invited from interested firms under two bid system for procurement of ‘**SEQUENCING SERVICES** (CUSTOM DESIGNED MICROARRAY, SAMPLE PROCESSING AND POST MICROARRAY DATA ANALYSIS)’ at ICAR-NRC on Pig, Rani,Guwahati.

Online submission of Bids through **Central Public Procurement Portal** (<https://eprocure.gov.in/eprocure/app>) is mandatory. **Manual/Offline bids shall not be accepted under any circumstances.**
2. Tenderers/Bidders after submission of their bids online through CPP Portal must submit Hard Copy of all the submitted documents except Financial Bid (BOQ) alongwith Tender Fees and EMD which should reach at ICAR-NRC on Pig, Rani, Guwahati on or before **10.00 A.M, 19.12.2017** failing which their tenders/bids will not be considered.
3. Bidders submitted their tender against our Earlier Tender for **Sequencing Services** Vide No. **313/nrcp/2017-18/Equip(SS)** (Tender ID No. **2017_DARE_254040_1**) are also required to submit their bids online through Central Public Procurement Portal (<https://eprocure.gov.in/eprocure/app>). However, if the firm had submitted the Hard Copy of Tender with EMD & Tender Fees against the said tender in past to this office and required to consider the earlier HARD Copy of Tender with EMD and Tender Fees against this tender, a letter of request must be sent to this office **on or before 10.00 A.M, 18.12.2017.**
4. Tenderers/bidders are requested to visit the above website regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
5. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Institute reserves the right to accept or reject any or all the tenders.

6. The interested bidders are required to compulsorily deposit the Tender Fees and Earnest Money Deposit (EMD) of the amount mentioned against the items in any of the following ways:
 - a) Demand Draft/FDR-TDR/BG from any of the Commercial bank in favour of **DIRECTOR – ICAR-NRC ON Pig,Rani,Guwahati payable at SBI, Khanapara Branch, (Code – 09945)**. The Demand Draft/FDR-TDR/BG may be sent by speed post/Regd. Post or submit in person to the Admin. Officer, ICAR-NRC on Pig,Rani,Guwahati-781131 on or before the bid opening date & time as mentioned in the Critical Date Sheet. Tender fee & EMD submitted through Courier Services will not be accepted.
7. The payment of the Tender Fee & EMD by any of the above modes has to be invariably made on or before the bid opening date & time as mentioned in the Critical Date Sheet.

TECHNICAL SPECIFICATIONS.

Custom designed microarray, sample processing and Post Microarray Data Analysis

Specifications:

Microarray for profiling of gene expression, DNA methylation, acetylation, SNP and other similar analysis of samples from pig (Porcine, *Sus scrofa*). Customized array manufacture-The arrays should provide comprehensive coverage of genes/transcripts and probe sequence should be based on the publically available databases such as RefSeq/Ensembl/Entrez/Unigene/GO etc. The list of genes/IDs will be provided for design of arrays. The array should have flexible format to accommodate different set of genes/probes and number of samples. Different formats of arrays available may be indicated in the quote. Wide dynamic range of detection to differentiate low and high level of gene expressions. The quote should indicate detection system (single/multicolour) and planned flowchart for analysis of samples in the technical specification. The samples should be suitably processed using the custom designed array, scanned and data generated. The post array scanning analysis includes quantification of expression/methylation levels, functional annotation, pathway analysis, generation of relevant tables and figures and facilitate submission of data generated into public databases after analysis as advised. The entire work should be completed within 90days from date of pickup of samples. The used arrays have to be returned within 30days of analysis of samples to the institute for records. The complete service quote should include design of customized array, pickup of samples from the lab at ICAR-NRC on Pig, Guwahati or elsewhere, cost of reagents, processing of samples, scanning of arrays and analysis of generated data and comparison across samples/arrays.

Terms and conditions:

- 1. The data is to be supplied in soft copy (in email and Hard disk/Pen drive), the data analysis results in both soft and printed copy.***
- 2. Approximate number of samples to be analyzed is 15 and the prices have to quoted on per sample basis***
- 3. The Director, ICAR-NRC on Pig reserves right to place order or not and alter the number of samples.***
