1. The Tenderers should be authorized Transport Agency with trade license. Copy of trade license must be attached alongwith tender form failing which tender will be rejected.

DOCUMENTS REQUIRED: The Agency must submit the following documents alongwith their tender failing which their tender will be cancelled.

- a) Tender Fees of Rs. 500.00 (Rupees Five Hundred) only (Non-refundable) in form of demand draft drawn in favour of "Director, NRC on Pig" payable at SBI, Khanapara, Guwahati must be enclosed alongwith the quotation. Tenders without Tender Fees will be rejected.
 - b) EMD of Rs.5000.00 (Rupees Five thousand) only (refundable) in form of demand draft drawn in favour of "Director, NRC on Pig" payable at SBI, Khanapara, Guwahati must be enclosed alongwith the quotation. Tenders without EMD will be rejected.
 - c) Agency Bank Details.
 - d) Income Tax/Sales Tax Certificate of the Agency of last financial year.

2. The rate-contract will be valid for one year from the date of issue of work order, and no hike in the rate will be entertained, during the contract period.
 3. Mileage and time will be recorded from the point of reporting as per the instructions of the Vehicle i/c or Indenting Officer from time to time.
 4. Vehicles provided on hire to the Institute should be Commercial Vehicles and registered with the Transport Authority. Driver of vehicle should have a valid Driving licence.
 5. Parking charges etc. will be paid by the Institute on submission of receipt alongwith duty slips certified by the Office who has used the vehicle.
 6. Payment will be made on monthly basis by crossed cheque or through e-payment as per rule on getting original bills alongwith duty slips certified by the Officer of this office who has used the vehicle.
 7. Vehicle should be provided at short notice. Cleanliness of vehicles and its condition should be excellent. The vehicles on requisition should be in time. The Driver should be polite and well mannered.
 8. The successful bidder will have to deposit Security Money of Rs.10,000.00 (Ten thousand)only in the form of Demand Draft of any nationalized bank in favour of Director, ICAR-NRC on Pig, which will be refundable without interest after satisfactory completion of the contract period.
 9. Penalty etc. imposed by traffic police/department, will not be paid by the Institute.
 10. The applicable taxes will be paid as per Govt. of India Guidelines.

11. If the Agency fails to provide the vehicles (s) on requested in time after receiving the message, the Institute reserves the rights to cancel the above mentioned contract at any time without assigning any reason.
12. Incomplete quotation, quotation received late/those not in compliance with the terms & conditions will be rejected.
13. Original Bills submitted by the Agency should accompany the "Duty Slips" depicting out meter/in meter; Total run in KM and out time/in time; Total duty period in hours duly signed by the indenting/Availing Officer.
